#### **Pool Reminders**

General Housekeeping. Please roll down the umbrellas in the pool area after use. Please clean up after your guests when leaving the pool area. Dispose of all garbage, Band-Aids, etc. Please do not take glass of any kind into the pool area. Also please remember that smoking and/or alcohol are not permitted in the pool area.

Important Reminder. Babies and toddlers must wear swim diapers and a waterproof swim pant over the diaper per new restrictions to prevent contamination and the spread of any illness or disease. We are under county licensing for the pool and must adhere to those restrictions. In addition, anyone having diarrhea should not use the community pool until at least one week after symptoms subside.

Pool Hours. We recently tried to open the pool early morning for residents to swim laps. What we have found is that it makes our cleaning schedule impossible to keep as there is not enough down time to shock the pool with chemicals when needed. Unfortunately, we will not be able to offer the early morning swim time. As our pool is small, and heavily used by our residents, we have more chemical adjustments to do than if the pool were larger. We hope that you will all understand our decision to return to the posted hours of 9 a.m. to 10 p.m.. Also, the furniture will be cleaned Monday mornings between 9 a.m. and 10 a.m.

#### Pets

Leashes. Please remember that pets MUST be kept on leashes at all times when in common areas.

Feces. We continue to have problems with people not cleaning up after their pets. Please be courteous and take care of this matter! Residents found not cleaning up after their animals will be fined \$50.

### Parking

Street parking continues to be a problem in the community. Parking restrictions are in place by state and county laws to provide adequate room and access for emergency vehicles.

Parking in the street is allowed for loading and unloading purposes ONLY!

Residents may be fined \$50 for parking violations. If the parking issues continue, the board may be forced to hire a towing company to enforce these rules.
